### SECTION 1: OVERVIEW

---

Mission Resource Conservation District (MRCD) is a local government agency, headquartered in Fallbrook, California. The overview of the demonstration garden seeks to incorporate the three diverse departments of the District, which are landscape, agriculture and natural resources. A physical display of efficient practices for each is described in greater detail below.

The work described in this RFP is to be carried out only on the property referenced in the request.

The proposed time period for all work outlined in this RFP will be carried out is February 1, 2019 – September 30, 2019, weather permitting and flexible according to winning bidder scheduling needs.

### SECTION 2: OBJECTIVES

---

The main objective of this project is to demonstrate how conservation practices can be utilized to increase soil health, irrigation efficiency, and ecosystem functions. The goals of the Project are to transform the Project area from a low-quality site to a fully functioning pollinator habitat and demonstration site that uses an ecosystem based management approach. The Project seeks to educate agricultural producers and property owners on the importance of improved soil health, irrigation efficiency, and the benefits of incorporating native plants for pollination and soil health improvement. The visual and demonstrative native landscape, inclusive of raingardens, bio-filtration systems and pollinator gardens visualizes how to capture, conserve and treat water, in various ways, while making use of our water resources more effectively for human, native flora / fauna and habitat health.

Maps and photos of the trees in each of these three areas are included for reference in the next section.

## SECTION 3: SCOPE OF WORK

---

### Landscape

The scope of the project consists of the following elements provided below.

- Design of the entire space to reflect conservation practices indicative of each department
- Removal and disposal of dead vegetation
- Palm tree removal (1)
- Removal of large liquid amber trees and excavation of root system (2)
- Installation of new irrigation controller
- Removal of concrete curb
- Installation of bioswale
- Mulching
- Planting of native and other items

## SECTION 4: PROJECT TIMELINE

---

Below is a timeline for important activities and deadlines during both the application and implementation periods of this project:

- December 4, 2018: RFP is distributed
- December 17, 2018: Site walk @ 2:30 p.m.
- December 28, 2018: Last day to submit RFP questions to MRCD
- January 14, 2019: RFP responses due
- January 25, 2019: Announcement of award
- February 1, 2019 – September 30, 2019: Start and end date for demonstration garden

## SECTION 5: CONTRACTOR MINIMUM REQUIREMENTS

---

Below is a list of **mandatory** requirements for the contractor(s) to carry out work included in the RFP:

1. The organization must comply with prevailing wage law and be currently registered as a Public Works Contractor with the California Department of Industrial Relations.
2. The organization must provide proof that its subcontractors will have all necessary licenses, permits, qualifications and approvals of whatever nature that are required to legally practice its profession and/or perform services under this Agreement at all times during the term of this Agreement.
3. The organization must have experience safely removing 45+ foot trees from residential areas and near sensitive structures such as power lines and homes with lumber preserved for milling.
4. The organization must be prepared to execute the Professional Services Agreement with no revisions.

## SECTION 6: SUBMISSION GUIDELINES

---

### Submission Format

The proposal submission for the RFP should be structure using the following sections:

1. Background on the organization
2. Action Plan – this section includes general strategies for removing trees around sensitive structures such as power lines and homes.
3. Budget – please include a single cost for all project work and an hourly wages sheet to be used in the event that extra work beyond the original project scope is deemed necessary. MRCD and selected contractor must agree on scope and budget of extra work prior to implementation and payment.

## SECTION 7: EVALUATION CRITERIA AND RESPONSE TIMELINE

The following criteria and weights will be used to evaluate proposals in response to this RFP:

1. The vendor meets minimum requirements outlined in Section 5: Contractor Requirements section: Either considered or not considered.
2. How well the proposal presents solutions to the problems identified in the Objectives section of this RFP: 50%
3. The extent that the proposal communicates a clear and concise action plan: 50%

### Acceptance of Proposals

- MRCD reserves the right to accept or reject any and all proposals, or any item or part thereof, or to waive any informalities or irregularities in proposals.
- MRCD reserves the right to withdraw this RFP at any time without prior notice, and MRCD makes no representations that any contract will be awarded to any Proposer responding to this RFP.
- MRCD reserves the right to postpone proposal openings for its own convenience.
- MRCD reserves the right to require confirmation of information furnished by Proposer, or to ask the Proposer for additional evidence of qualifications to perform the work, or to obtain information from any source that has the potential to improve the understanding and evaluation of the proposals.
- Proposals received by MRCD become public information and will be made available to the public upon request after award.
- Proposals submitted are not to be copyrighted.

All entities submitting responses to this RFP will be notified of the final decision of award of contract by 4 pm on January 25, 2019.
